## Purpose:

To outline the residential contraband policy to stakeholders.

## Application:

Applies to all residential locations within EOSIS.

## Policy:

- EOSIS shares a list of items which may or may not be allowed in residential facilities during treatment. The purpose of these lists is to ensure the safety of the patient community as well as all staff.
- 2. All patients and visitors are required to abide by this policy.
- 3. Staff are not permitted to use contraband items in the presence of patients, unless required for a specific work purpose.
- 4. Any items in the facility are subject to being searched, stored, or confiscated for the safety of the community.
- 5. Contraband and Under Supervision items will be documented in the patient's record. Return or destruction of items will be documented in the patient's record.
- 6. Patients will be provided Contraband Policy no later than time of admission.
- 7. Visitors will be provided with the list of items allowed and not allowed in residential facilities prior to visiting hours and/or reviewed prior to them entering the facility.
- 8. At each facility, this policy will be posted and available for review by patients, visitors, and staff.

#### Procedure:

A. **Contraband:** The following items are not allowed in EOSIS facilities. Personal items may be sent home with referent or other concerned person at the start of your stay. Weapons, illegal items, non-permitted substances and food items, as listed below, will be confiscated, secured, and/or destroyed. Contraband substances, substance use containers, and substances of abuse paraphernalia will be forfeited, and either destroyed by staff or given over to the custody of local law enforcement in accordance with 42 CFR Part 2. Law enforcement will be consulted for the potential surrender or securing of weapons, explosives, and other items that may cause serious harm to self or others. EOSIS staff will notify patients of the action taken and their right to reclaim any lawful property upon discharge. Without a release of information on file, staff are generally not permitted to disclose to Law Enforcement the identity of the patient.

#### a. Substances

- i. No substances of abuse, substance of abuse paraphernalia, or alcohol.
- ii. No instant coffee.
- iii. No vapes of any kind.
- iv. No chewing tobacco.
- v. No Zyns or other nicotine pouches.
- vi. No nicotine inhalers or intranasal spray

- vii. No opened loose leaf tobacco packages or opened packages of cigarettes.
- viii. No Nicotine Patches.
- ix. No products containing CBD oil or alcohol.

## b. Food and Drinks

- i. No open food or drinks of any kind are allowed.
- ii. No perishable foods: any food that spoils or decays if not refrigerated.
- iii. No fruit.
- iv. No food items in glass jars.
- v. No canned items.
- vi. No energy drinks or canned coffee
- vii. No protein shakes, bars, or meal supplements unless a provider's order is provided.
- viii. No aerosol food products (i.e., spray cheese)
- c. No personal over-the-counter medications.

# d. Weapons

i. No weapons of any kind including but not limited to pocketknives, pepper spray and other personal safety devices.

### e. Electronics

- i. No Bluetooth speakers or stereo systems.
- ii. No humidifiers, or dehumidifiers.
- iii. No smart watches,
- iv. No fragrance wall-plug ins.
- v. No Electric toothbrushes, electric waterpik, and teeth whiteners.

#### f Clothing

- i. No provocative clothing (body must be well-covered).
- ii. All leggings must be paired with shirts that are long enough to cover the buttocks.
- iii. No clothing or bandanas of any kind with chemical use or gang related slogans including but not limited to bars, casino, swearing, or related graphics.

## g. Personal Care Items: all products must be alcohol free.

- i. No hairspray in spray-pump bottles unless it's alcohol free.
- ii. No needles, sewing kits, push pins, safety pins, etc.
- iii. No metal nail files.
- iv. No pumice stones or pedicure tools.
- v. No perfume, body spray, or unmarked containers of any kind.
- vi. No nail polish, nail polish remover, acrylic nail sets, glue on nail kits, nail glue, manicure tools, etc.
- vii. No super glue, oil-based paint, or sharpies
- viii. No eyelash curlers
- ix. No aerosol products of any kind.

### h. Miscellaneous

- i. No keys of any kind.
- ii. No tarot cards or poker chips.
- iii. No Skateboards, roller blades, or bikes.

- iv. No rugs of any kind (unless for religious/cultural purposes).
- v. No personal workout equipment (i.e., dumbbells, weights, weighted vests, etc.)
- vi. No pornographic material or sex objects (dildo's, vibrators, masturbation items) of any kind.
- vii. No glass or ceramic items.
- viii. No air fresheners, candles, warmers, incense, etc.
- B. **Under Supervision:** Under Supervision items will be stored in a staff area, sometimes held until a set time for use. You must return the items to the RS or Nursing staff immediately after use. If it is found in your room, it will be taken away, and you may not be able to use this for the rest of your treatment. All products must be alcohol free.
  - a. Razors
  - b. Hair Clippers
  - c. Shaving cream
  - d. Nair or hair removing products
  - e. Personal sage or other smudging materials
  - f. Workout bands
  - g. Personal Electronic Devices, such as cell phones, tablets, hand-held game systems and smart glasses are allowed under certain circumstances. Review the Cell phones, tablets, laptops are generally only permitted under direct monitoring from a member of the treatment team (counseling, MHP, or CPRS staff, with Treatment Director permission) for a specific, therapeutic purpose.
    - i. In some programs, patients may earn access to their electronics after advancing in treatment and graduating levels.
    - ii. Individual facilities may have additional rules or access guidelines prior to any electronic use; however, all electronic use must be:
      - 1. appropriate: no speaker phone, playing music/sound for others to hear, no inappropriate language, etc.
      - 2. During facility-set staff observed electronic times times will not change to accommodate patient schedules.
      - 3. ensuring confidentiality: No pictures, videos, or voice recording are to be taken.
- C. **At Facility Discretion:** The following items are only allowed at some EOSIS facilities or under special circumstances. Check with staff/Treatment Director at the facility.
  - a. Hair dryers, curling irons, flat irons
  - b. Fans
  - c. Night lights/heated blankets/sound machines/etc.
  - d. Suitcases, duffle bags, totes, tote bags, crates, boxes, etc.
  - e. Craft supplies, gel pens
  - f. Personal pens
  - g. Spiritual Items
  - h. Musical instruments (i.e. guitar, drums, harmonica, keyboards, etc.).
  - i. Personal essential oils

- j. Headphones for MP3 players or iPods allowance of noise cancelling headphones will be at the facility discretion.
- k. Smart glasses: must be accompanied by a provider order
- D. **Approved Items:** Approved items are kept in your room or locker. Any item may be taken away if it is being misused or interfering with yours/others treatment.
  - a. 2 grocery bags worth of food at a time in factory packaging, un-opened, non-perishable.
    - i. Crystal light, non-caffeinated Mio, or other individual packs of drink flavoring.
    - ii. Coffee creamer, non-dairy only.
    - iii. All food must be stored in a sealed bin, locker, or lockbox, at facility discretion. Food may not be kept out in the patient room.
  - b. Personal Coffee Mugs: Plastic only
  - c. Personal Care Items:
    - i. 1 small make-up/hygiene bag
    - ii. Lotion, Deodorant, Shampoo, Conditioner: without alcohol
    - iii. Make-up: Alcohol Free Only
    - iv. Make-up remover without alcohol
  - d. 1 Pillow: Will be washed and dried, unless new in the original packaging
  - e. 1 Blanket: Will be washed and dried, unless new in the original packaging
  - f. Laundry basket or bag
  - g. 7 outfits worth of clothing (including PJs)
    - i. Other items brought to the facility will be sent home or stored until your discharge.
    - ii. Items cannot be traded out at any time.
  - h. Recommended no more 2-3 pairs of shoes and 1 pair of shower shoes
    - i. Anything more than this will be placed in staff held until your discharge.
    - ii. Items cannot be traded out at any time.
  - i. Tobacco:
    - i. Cigarettes packs must be brand new and unopened. Loose tobacco must be in a new, sealed bag.
    - ii. Nicotine gum or lozenges with provider order.
  - j. MP3 players without internet access or a camera. The MP3 player must be already loaded with music.
    - i. Headphones to listen to MP3 player, facility will determine which type of headphones are allowed (noise cancelling vs not)
  - k. Books, personal journals, coloring books, pencils/crayons
  - I. Playing Cards
  - m. Approved, Alcohol-Free Options

- E. **Medical Products:** Prescription medications and over the counter medications will be given to the nursing department at initiation of service. Medication will be administered per the Medical Services policy. Prescribed medications, determined by the medical provider to be contraindicated or harmful, may be discontinued. The patient's personal physician will be notified, if applicable. Prescription medications that were determined by the facility's medical provider to be harmful after examining the patient will not be returned to patient at service termination except when the patient's personal physician approved the medication for continued use.
- F. **Personal Funds:** Facilities strongly encourage patients to not have more than \$50.00 at a time while in programming. Amounts greater than \$50.00 may be stored in the facility safe in a sealed envelope signed by the person served and a staff witness.
  - a. Whenever the facility assists a person served by the program with the safekeeping of funds or other property, the facility must:
    - i. Ensure the separation of funds of persons served by the program from funds of the facility, the program, and/or program staff.
    - ii. Immediately document receipt and disbursement of the person's funds or other property at the time of receipt or disbursement, including the person's signature, or the signature of the conservator or payee; and
    - iii. Return to the person upon the person's request, funds and property in the facility's possession subject to restrictions in the person's treatment plan, as soon as possible, but no later than three working days after the date of request.
  - b. Patients are ultimately responsible for their unsecured funds. EOSIS is not responsible for lost or stollen funds.
  - c. The Facility and its program staff will not:
    - i. Borrow money from a person served by the program;
    - ii. Loan money to a person served by the program;
    - iii. Purchase personal items from a person served by the program;
    - iv. Use funds of persons served to purchase items for which the facility is already receiving public or private payments.
- G. **Emotional Support Animals:** EOSIS residential facilities recognize support animals as patient property. Limitations related to feeding, health, safety concerns, and the nature of

personal property, support animals will not be accommodated within EOSIS residential programs. Service animals are accommodated in accordance with EOSIS policies.

H. **Abandoned Property:** Abandoned property will be retained for 30 calendar days. After that period of time, the facility is no longer responsible for the property, and it will be disposed of. Disposal of property will be documented and kept with a copy of the patient's valuables sheet.
